# PRIVILEDGE OF THE FLOOR: John Hotto of LandTech- Rezoning of Tax Map #29.00-1-86.2 (2.5 acres at the SW corner of Plastermill and Loomis Roads

Mr. Hotto from LandTech representing Edward Samoel, owner of the property. The developer is proposing the construction and operation of (2) 10,000 sq. ft. flex space warehouse buildings at the corner of Plastermill and Loomis Roads. He stated that currently the site is zoned General Business which does not allow the use of the property for warehouses. He stated that they have been in consultation with Ron Brand about proposing a rezoning action to General Industrial zoning district where warehouses are permitted. The site is about 2.5 acres surrounded by a lot of space, road right of way space primarily, and it is heavily wooded right, however there are dying ash trees. He stated that the site is very flat and generally drains towards Plastermill Road, but they have enough grade to provide for stormwater management basin and allow the water to be released. All utilities are available. Mr. Hotto stated that they have applied for setback variances with the Zoning Board of Appeals. A Conceptual Site Plan was shown and reviewed. They are respectfully asking the Board to consider rezoning the property from General Business to General Industrial District. Councilman Bowerman asked where the entrance would be located. Mr. Hotto replied next to the existing Park-n-ride driveway. Councilman Casale asked how they would provide security. Mr. Hotto replied through the use of cameras and whatever other security devices that are needed.

Mr. Brand stated that the applicant and their engineer met with staff to discuss the project on a few occasions. He stated that the reason for the access easement for the Park-n-ride lot to this facility was to eliminate driveways coming out onto east of its location given the short separation between intersections. He added that from a zoning standpoint this area was zoned GB years ago when the railroad crossing was running great and there was a toll booth as well to get to Loomis Road and Plastermill Roads and it was changed by the Route 332 design. Mr. Brand stated that the Zoning Officer evaluated this and identified the constraints to develop under GB and they feel it is something that should be sent to the Planning Board for a review and recommendation. Councilman Holtz asked if most Loomis Road is Industrial, Mr. Brand replied that it is mostly General Business, with the exception of the hotel.
